On Saturday, 06-15-13 at approximately 1444 hours, I was dispatched to the Mineral Wells Police Department lobby, in reference to Terroristic Threat.

Upon arrival, I made contact with Amanda Lorraine Lollar, (listed victim), who is the founder and President of Bat World (217 North Oak Avenue). Lollar told me the following:

In June of 2010, a Mary Katherine Cummins, (listed offender - no identifiers at this time), came to Mineral Wells to attend a internship at Bat World, with Lollar. Cummins lives in California. Cummins left before the internship was completed. Cummins then initiated an online campaign to defame Bat World and Lollar. In June of 2012, Lollar and Bat World was awarded \$6.1 million dollars in a judgement against Cummins.

Since this judgement, Cummins has made several threats towards Lollar and her attorney. Most of these threats state that Cummins is going to shot Lollar with a gun. Cummins describes in detail that she has the gun, gun permit, and the bullets. She has also stated that the LAPD has instructed her to shot Lollar if she comes around her. Lollar stated that she is in fear of serious bodily injury from Cummins, or someone that she may have hired to come to Mineral Wells.

Lollar stated that she has Cummins' address and phone number at home.

The paper work that Lollar brought in showing the history between herself and Cummins, and the threats by Cummins, was placed into Mineral Wells Police Department Property Vault.
