Defendant Mary Cumminss Ex Parte Motion to Strike Subpoena, Disallow Non-Party Records, Objection to Video, and Request Protective Order is DENIED. The moving party has failed to submit a written declaration demonstrating that timely notice of this ex parte application was given to all parties, i.e. by 10:00 am the court day before the ex parte appearance.
