1 Appellee and plaintiff Konstantin Khionidi, as Trustee of the Cobbs Trust in the
2 above-captioned adversary proceeding case and the Appellee herein (“Appellee”) hereby
3 submits this short Reply to the so-called “opposition” filed by appellant Mary Cummins-
4 Cobbs. As grounds therefor, Appellee states the following:

5 1. Stripped of the usual misrepresentations and irrelevancies by which Cummins
6 has dragged out the adversary proceeding for two years, Cummins contends that because
7 she had trouble getting access to electronic filing, apparently beginning some time in
8 March, she should be excused from timely prosecuting what can only be called a frivolous
9 appeal.

10 2. However, the Designation of Issues, Designation of Record and Designation of
11 Transcripts were due on February 27, 2020. She does not explain why she simply didn’t
12 file the required documents with this Court as she has filed countless documents in the
13 bankruptcy court. She also fails to explain why, despite two notices, on April 2 from the
14 bankruptcy court and again on April 9 by this Court, she literally did *nothing* until today,
15 and then only because Appellee finally requested that the appeal be dismissed.

16 3. A review of the adversary proceeding docket shows that Cummins has been
17 perfectly able to file documents when she wants to and indeed, has filed numerous
18 documents between February 27 and today in the Bankruptcy Court, showing that had she
19 wanted to, she could have complied with this Court’s Order. For example, Cummins filed
20 the following documents in the Adversary Proceeding:

21 • February 27 (the day her appellate documents were due), a Reply
22 • March 12, an ex parte motion seeking to stay all proceedings,
23 • March 17, a second motion for a stay
24 • May 1, requesting a 30 day extension from the bankruptcy court.
25 • May 5, a notice objecting to closing the Adversary proceeding, even though
26 she already appealed the final judgment.

27 4. Thus, Cummins was perfectly able to file documents in the bankruptcy court
28 where she is not an ECF filer throughout the entire time she now claims that she was

1 having problems with ECF filing in this Court.

2 5. Moreover, this is by no means the first time that she has made claims of illness
3 or technical problems to evade deadlines. A good example of Cummins' repeated tactics
4 on this can be found in the Order from the U.S. District Court for the Northern District of
5 Texas in one of the several cases in which she sued Amanda Lollar, the original judgment
6 creditor, *Cummins v. Lollar*, 2015 U.S. Dist. LEXIS 182351 (N.D. Tex. June 16, 2015),
7 where the Court denied her motion for a stay based on alleged "back surgery." There, the
8 Court stated:

9 Plaintiff, who is proceeding pro se, claims that the limitation on her ability to
10 sit or stand for prolonged periods of time prevents her from being able to
11 adequately pursue her case because it impedes her ability to perform legal
12 research, draft legal documents, respond to discovery, or attend depositions.
13 Defendants note that Plaintiff has provided no evidence from a medical
14 professional supporting her claim of a "medical emergency." Defendants also
15 note that in the time leading up to the present motion, Plaintiff has maintained
16 an active internet presence, which includes numerous posts to a public Twitter
17 account and blog. This Court's own review of Plaintiff's publicly available
18 Twitter account and blog reveals numerous tweets and posts around the time
19 Plaintiff sought a stay based on a claimed medical emergency up until the date
20 of this order.

21 *Cummins v. Lollar*, 2015 U.S. Dist. LEXIS 182351, at *1-2 (N.D. Tex. June 16, 2015).

22 6. In addition, attached hereto are printouts of Cummins' Twitter account
23 showing computer access almost daily since March, as well as a printout of her Facebook
24 postings under her alter ego, "Animal Advocates." So in reality, Cummins had had plenty
25 of time and opportunity to prosecute this appeal and simply has not.

26 7. On April 9, this Court ordered Cummins to file a Declaration showing good
27 cause for her failure to comply with any of the procedural requirements for prosecuting an
28 appeal. She contends that her filing today responds to the April 9 OSC. It does not.
Although it purports to be signed under penalty of perjury, the filing is stuffed with
nonsensical claims that have been repeatedly rejected by the bankruptcy court. Moreover,
this bankruptcy appeal is suitable for summary disposition, since it is literally frivolous and
without any good faith basis.

8. Given Cummins' failure to comply with her obligations to move this appeal

1 forward despite repeated notices from this Court and the bankruptcy court, her failure to
2 respond to this Court's OSC and the total and complete lack of any merit to her appeal, this
3 Court should dismiss the Appeal for lack of prosecution.

4 WHEREFORE, appellee Konstantin Khionidi, as Trustee of the Cobbs Trust,
5 respectfully requests that this Court dismiss the appeal for lack of prosecution.
