on March 18, 2021 [ECF 202] and (2) denying Defendant's "Motion to Rehear" which was entered on April 27, 2021 [ECF 208].

Appellee stated the Appeal is substantially related to a previous appeal in Cummins-Cobb v. Khionidi, Case No. 2:20-cv-02149-AB (C.D.Cal. Jan. 7. 2021) stating Appellant is "seeking literally to re-argue the issues already decided in the prior appeal." This is false. Appellant raises an issue which was not previously under appeal. The issue is that Plaintiff Konstantin Khionidi does not exist. A party who does not exist cannot file a lawsuit per Federal Rules of Civil Procedure 17(a) "An action must be prosecuted in the name of the real party in interest.".

Appellant objects to proceeding in the District Court. District Court Judge Andre

Appellant objects to proceeding in the District Court. District Court Judge Andre Birot who oversaw the prior case refused to hear any motions. Appellant lost the motions by default because Judge Birot refused to hear them Docket 2:20-cv-02149-AB. It's clear that Judge Andre Birot and the District Court don't have the time to hear the case.

Judge Birot is also prejudiced against pro se parties based on Judge Birot's actions and words. Judge Andre Birot refused to make any allowances for an indigent pro se party during the beginning of the pandemic. Ultimately the Court system finally made allowances for pro se parties during the pandemic. Appellant would have lost had it not been for those allowances made solely by the Court system.

For these reasons Appellant requests that the case not be transferred to the District Court or to the Court of Judge Andre Birot.
