1 I, Philip H. Stillman, hereby declare:

2 1. I am counsel of record for plaintiff in this adversary proceeding and a member of  
3 the California State Bar in good standing. I have personal knowledge of the facts stated herein  
4 and if called as a witness, I could and would testify competently to them.

5 2. After receiving this Court's Order regarding an evidentiary hearing, and again trying  
6 to save time and energy over Cummins' claimed non-receipt of the check that I mailed, I  
7 contacted her via email to again see if I could electronically transfer \$35 via Venmo or PayPal so  
8 that there would be (1) immediate payment and (2) unquestionable proof that Cummins received  
9 the \$35. Cummins refused to provide said information.

10 3. However, at the time of this Court's Order, I was in a private in-person trial being  
11 conducted at JAMS in San Diego, and did not have a check book to again attempt to get a check  
12 to her. However, on Wednesday, September 2, I had to return to Miami due to a family  
13 emergency, and on Friday, I arranged with a client and former colleague to personally drop a  
14 check for \$35 off to Cummins, so that there could be no further gamesmanship about whether  
15 she did or did not receive her \$35.

16 4. At my request, Mr. Hoffman personally delivered the \$35 check to Cummins'  
17 residence. A copy of the check with the account number redacted is attached hereto as Exhibit  
18 1. In an email to Mr. Hoffman, Cummins confirmed receipt of the check, asking "if it was good."  
19 A true and correct copy of the email from Cummins is attached hereto as Exhibit 2.

20 5. My father is on his deathbed and in light of the incontrovertible fact that Cummins  
21 has now received the \$35 check, regardless of whether she received the prior check, I ask that  
22 the evidentiary hearing be vacated and the OSC discharged.

23 I declare under penalty of perjury under the laws of the state of California and the United
