18 MINUTES (IN CHAMBERS) ORDER AFFIRMING BANKRUPTCY COURT
19 ORDERS in Defendant's Appeal Motion to Dismiss in this case. Defendant
20 completely disagrees with Judge Birot's ruling for many reasons. The main reason is
21 that to this day the real Plaintiff Amanda Lollar of Bat World Sanctuary states that
22 Amanda Lollar is "KonstantinKhionidi" who does not exist and is not a real person.
23 Per Federal Rules of Civil Procedure 17(a) "An action must be prosecuted in

1 the name of the real party in interest.” It further makes any contract, agreement,
2 assignment of a judgment null and void. Case should be dismissed.

3 Defendant intends to appeal the final judgment of the Adversary Proceeding case. If
4 for any reason that Appeal is denied, Defendant will dismiss the entire bankruptcy
5 case. Defendant only filed it because of this one ridiculous and meritless judgment. Do
6 not close the Adversary Proceeding or Bankruptcy case if the judgment is not
7 dismissed.

8 Defendant is not an attorney or in the legal field but a pro se party. Because of the
9 New Year holiday the pro se clinic and other free legal aid resources are closed.
10 Defendant needs to meet with legal aid. Defendant will be filing the Notice of Appeal

16 protective order. The DMV information was obtained when Plaintiff forged
17 Defendant’s information to illegally obtain the documents from the DMV. The DMV
18 data was also not relevant as the auto was exempted from the bankruptcy case by the
19 trustee in January 2018.
