Defendant Mary Cummins' Motion to Vacate or Modify Renewal of Judgment is DENIED. The

The issue of the creditor's standing has already been conclusively and finally resolved in the creditor's favor in an adversary bankruptcy proceeding. That ruling has collateral estoppel effect here and is binding on Ms. Cummins. (In re Cummins-Cobb (Bankr. C.D. Cal. Feb. 10, 2020) No. 2:18-ap-01066-RK, 2020 WL 634140, at *13; Cummins-Cobb v. Khionidi (C.D. Cal. Jan. 7, 2021) No. CV 20-02149-AB, 2021 U.S. Dist. LEXIS 5154, at *5-6; Cummins-Cobb v. Khionidi (C.D. Cal. Dec. 21, 2021) 2021 U.S. Dist. LEXIS 247738, *1, 2021 WL 8017854.)

Further, the application for renewal of the judgment is timely. The court entered the judgment on the sister-state judgment on November 9, 2012. The application of renewal was properly filed within 10 years of that date. Further, the time for filing the application for renewal was tolled while the action was stayed during the bankruptcy. (Rubin v. Ross (2021) 65 Cal. App. 5th 153, 167.) The court further finds that the renewed judgment was properly served.

Proc., §685.010, subd. (a).) When a sister state entry of judgment occurs, "[f]rom the time of entry, interest shall accrue on the judgment so entered at the rate of interest applicable to a judgment entered in this state." (Code Civ. Proc., § 1710.25, subd. (b).) Here, Here, the court entered judgment on the sister-state judgment on November 9, 2012. Counsel calculated judgment from the time the California entry of judgment occurred to the present at the proper rate of 10%
